NERAMAC shall not be responsible for any late receipt of applications for any reasons whatsoever. The applications received late will not be considered.

NERAMAC may include any other item in the Scope of work at any time after consultation with applicants or otherwise.

The NERAMAC reserves the right to relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the NERAMAC without assigning any reasons thereof.

In case the date opening falls on a holiday, the bids shall be opened on next working day at the same time and it will be binding on the Tenderer/ Bidders for acceptance.

The objective of seeking Expression of interest is to empanel Architectural Consultants & Interior Designers.

The scope of work for architectural firms is to prepare master plans/site plans, concept plans and designs, detailed architectural drawings, construction plans and drawings, service drawings, cost estimates, period in site supervision and other related services for various types of buildings/projects under NERAMAC. Depending on the nature of the work, it may also be necessary from time to time to undertake the execution of the project through a sub-contract with another contractor.

The scope of work for interior designers is the preparation of concept plans, detailed drawings, material specifications, construction plans and drawings (if required), service drawings, cost estimates and regular site supervision for various types of upcoming interior design projects under NERAMAC.

Interested architectural consultants and interior designers can apply with their credentials/information/ certificates in the prescribed format available on the NERAMAC website.

The application for the same is to be sent to the Managing Director, North East Regional Agricultural Marketing Corporation, Guwahati, super-scribing on the top of the envelope "Empanelment of Architectural Consultants & Interior Designers" The duration of the contract will be valid for a period of 3 (three) years from the date of empanelment.

## PART-I (A)

Instruction to the Applicants before filling up of Application form:

 Individual architects or a firm of architects is eligible for empanelment. The consultancy firm / Architect should be registered with the Council of Architecture (COA) India.

#### 2. Eligibility criteria

The agency should have extensive experience in preparation of DPR, Master plan/ site plan, architectural detail drawings, structural design and drawing, services drawing, cost estimate and other related services for different categories of buildings under Govt./ public sector undertaking and any other reputed organizations during last 5 years ending 31 March, 2022. The consultant should be in a position to provide his services in the NER as well as per requirements of the Corporation. Architectural firms with a focus on sustainable, ecological and culturally sensitive designs that have been vetted through international awarding bodies will be prioritized.

3. Empanelment will be made for the following categories depending upon project cost:

Category-A (Work value 5.0 crore and above)

Category-B (Work value 10.0 crore and above)

Category-C (Work value 20.0 crore and above)

Category-D (Work value 50.0 crore and above)

- 4. The applicants shall be signed by the persons on behalf of the organization having necessary authorization/ power of attorney to do so. Each page of application shall be signed (copy of power of Attorney / Memorandum of association shall be furnished along with the application and Original should be produced subsequently for verification and return).
- Intending applicants are required to submit their full Bio-Data in duplicate giving details about their organization, experience, technical personnel in their organization, proven competence to handle major works in the enclosed Proforma.
- 6. Both the forms of applications (original and duplicate copy) shall contain copies of all the enclosures separately.
- 7. If the space in the proforma is insufficient for furnishing full details, such information may be supplemented on separate sheets stating therein the name of the Proforma

- and serial number. Separate sheets shall be used for each part of the application. Separate sheets must be duly signed and sealed.
- 8. The applicant must have at least two qualified graduate Architects (having minimum of 5 years experience of preparation of concept plan, structural design & drawing, services, landscape ancillary works and cost estimation.
- 9. The applicant shall, with the prior approval of the Corporation and within the agreed fees, engage the services of well qualified specialists or consultants pertaining to the following services:
- Structural
- Electrical
- Sanitary, drainage and water supply
- Air conditioning
- Fire fighting
- Preparation of sub-soil investigation report.

The fees of the specialists/ consultants appointed under this clause shall be paid by the empanelled architectural firms, who shall be responsible for all consultancy services.

- 10. While filling up the application with regard to the list of important projects completed or on hand, the applicants shall include a separate sheet in the prescribed format.
- 11. Services to be rendered by the consulting firm:
  - A. To take instruction from the Corporation and prepare sketch designs/ presentation drawings making revisions till sketch designs are finally approved by the Corporation and making preliminary estimates of cost.
  - B. To prepare architectural working drawings, structural drawings including detailed design calculation, services drawings- electrical, plumbing, sanitary, fire fighting and all other drawings for various trades required for completion of the particular project.
  - C. To draw detailed specifications, estimates, rate analysis.
  - D. To prepare and supply all drawings for execution.
  - E. To visit the site periodically when the work is in progress.
  - F. To submit as built Drawing after completion of project
  - G. Any other services in connection with the said works and normally rendered by the Architect and not referred to in above.
  - H. To conduct Sub-Soil investigation works as directed by the Mission and preparation of sub-soil investigation report by the sub-soil investigation Agency only.

12. Empanelment will be made on the basis of scores achieved, as determined by evidence of previous experience, International recognitions, experience of team leaders and financial strength of the firm, as indicated in the table below:

- 13. Decision of the Corporation in regard to preparation of panel of the architects shall be final. The department is not bound to assign any reasons thereof
- 14. The panel of firms once prepared, shall be valid for a period of three years and the Corporation is free to reduce/ extend this time limit at its discretion.
- 15. Terms of professional engagement including the Scope of comprehensive architectural services and fee structure/ payment terms applicable for empanelled

Architects shall be as stipulated in guidelines issued by the Council of Architecture (COA) constituted by the Government of India under the provisions of the Architects Act, 1972.

- 16. The firm for any particular work shall be selected from the respective panel at the discretion of the Corporation and such selected firms are required to execute agreements as per existing norms of the department.
- 17. Applicants furnishing false and/ or incomplete information are liable for rejection.
- 18. Advocating at any level for empanelment will be treated as demerits of the firm/ agency and will be liable for rejection.
