North Eastern Regional Agricultural Marketing Corporation (NERAMAC) invites sealed Expression of Interest of empaneled architectural consultants for Concept and Construction of one Permanent structure and one Temporary Gate spreading across an area of around 2000 sq. feet for the event of 'Surajkund Mela' scheduled to take place from 03 – 19 February 2023 at Faridabad, Delhi-NCR.

In case the date opening falls on a holiday, the bids shall be opened on next working day at the same time and it will be binding on the Tenderer/ Bidders for acceptance.

The objective of seeking Expression of interest is to finalise the Architectural Consultants amongst those empanelled with NERAMAC for execution of work at Surajkund, Faridabad, India.

The scope of work for architectural firms pertains to one Permanent structure and one Temporary Gate in which the requirement is to prepare master plans/site plans, concept plans and designs, detailed architectural drawings, construction plans and drawings, service drawings, cost estimates, period in site supervision, construction and other related services for the event of 'Surajkund Mela' scheduled from 03 – 19 February 2023 at Faridabad, Delhi-NCR under NERAMAC on or before20 January 2023.

Interested empaneled architectural consultants may apply.

The application for the same is to be sent to the Managing Director, North East Regional Agricultural Marketing Corporation, Guwahati, super-scribing on the top of the envelope "Construction of Commemorative Structure and Temporary Gate for Surajkund Mela". The duration of this contract will be valid for the event only.

Selection will be made on the basis of presentation of design, concept and financial quote made to a committee formed at NERAMAC. The design eventually would be subject to approval of Ministry of DoNER. While the overall budget would be a factor,

greater weightage would be given to the design and concept as the event is of National significance.

Decision of the Corporation in regard to award of contract to the architects shall be final. The department is not bound to assign any reasons thereof.
